

**COACHING RESOURCE, INC (D/B/A: CHOICE PERFORMANCE)
LORAL'S BIG TABLE AGREEMENT**

[STANDARD TERMS AND CONDITIONS ATTACHED TO PROGRAM REGISTRATION FORM]

This Agreement is effective between, "Client" described in the "Program Registration Form" attached hereto and incorporated herein by reference on the "Effective Date" set forth on the Program Registration Form. Coaching Resources, Inc. (d/b/a: Choice Performance) is described in these "Standard Terms and Conditions" as "CRI/CP", which is a California Corporation with offices located at 394 Bel Marin Keys Blvd, Suite #2, Novato, CA 94949. Client and CRI/CP may be referred to in this Agreement collectively as Parties or individually as "Party." The Parties in consideration of the promises and agreements set forth herein agree as follows:

1. Services and Payment

Client engages CRI/CP, and CRI/CP agrees to undertake and provide a program of services to the Client as defined in the Program Registration Form attached hereto and incorporated herein by reference. As consideration for providing this Program of services, Client agrees to pay CRI/CP in accordance with Program Registration Form. Client acknowledges that the Program of services does not include any financial advice or financial consulting.

2. Ownership; Rights; Proprietary Information; Publicity

- a. CRI/CP shall own all right, title and interest (including patent rights, copyrights, trade secret rights, trademark rights and all other rights throughout the world) relating to any and all works of authorship, designs, know-how, ideas, course materials, and information made or conceived or reduced to practice, in whole or in part, by CRI/CP in connection with the Services or any Proprietary Information (as defined below).
- b. Client agrees that all course and coaching materials provided by CRI/CP as part of the Services constitute CRI/CP's "Proprietary Information." Client will hold in confidence and not disclose or copy any Proprietary Information, except with the prior written consent of CRI/CP. CRI/CP will hold in confidence and not disclose any of Client's Proprietary Information that it receives in connection with its performance of the Services. However, neither party shall be obligated under this subsection with respect to information the other party can document is or becomes readily available to the public without restriction through no fault of that other party. Upon termination and as otherwise requested by notice from one Party to the other, the Party receiving notice will promptly return to the other Party, all items and copies containing or embodying the other Party's Proprietary Information, except that the Parties may keep their personal copies of their compensation records and this Agreement. Client agrees that to assist in monitoring performance under this Agreement, CRI/CP may record telephone calls between CRI/CP or its coaches and Client.
- c. As additional protection for the Proprietary Information and for CRI/CP's efforts to provide coaches who will assist in providing the Services, Client agrees that during the effective period of this agreement, including any extensions and for two (2) years thereafter, it shall not solicit for employment, any coach, associate or employee of the CRI/CP assigned to work, assist or provide the services under this agreement, without the prior written agreement of CRI/CP. This provision shall not apply to general advertisements for employment in the mass media.

3. Participation and Attendance by Client Required

- a. Due to the nature of this Program it is expected that Client will attend each in-person event. If Client cannot attend each event, Client may be removed from the Program pending a conversation with Lorale Langemeier. Client may not transfer to another Program, or make up lost days of Program attendance.
- b. It is further expected that Client will actively participate in the weekly and monthly mastermind calls.
- c. During the course of this Program Client will have coaching sessions scheduled with CRI/CP. In the event that Client wishes to re-schedule a coaching session, Client will notify CRI/CP in writing at least 24 hours prior to the scheduled session. If the Client provides notice with less than 24 hours to CRI/CP, the session will be forfeited.

4. Termination and Cancellation

- Due to the nature of this Program, CRI/CP will accept cancellations only as set forth hereafter:
- a. If Client terminates the agreement 45 days or more prior to the first day of the first in-person event, the Client shall be entitled to a refund of the tuition price for the Program minus an administration fee of \$300, plus the cost of any coaching, products and services provided prior to the notice of cancellation.
 - b. If Client terminates the agreement 44-22 days prior to the first day of the first in-person event, the Client shall be entitled to a refund of 50% of the tuition price for the Program minus an administration fee of \$300, plus the cost of any coaching, products and services provided prior to the notice of cancellation.
 - c. If Client terminates the agreement 21 days or less prior to the first day of the first in-person event, the Client shall not be entitled to a refund.
 - d. Client has the option of a one-time transfer to the next available Lorale's Big Table or Coaching Program. A transfer 21 days or more prior to the

first in-person event incurs a \$300 administration fee, 20 days or less incurs a \$1000 fee.

- e. There will be no refund issued if Client drops from Program during the year.

100% Satisfaction Guarantee

If you physically attend the event, actively involve yourself in the learning, and do not find that it meets your expectations or needs, you will receive a full refund of the tuition price for the Program. In order to receive this refund, you must make your request in writing and turn in your course materials to a member of the CRI/CP team prior to the start of the second day of the first in-person event. All refunds are paid after first subtracting the cost of any coaching, products and services provided prior to the notice of cancellation.

5. Payments

- a. If the Client chooses the one time payment option, this will guarantee your seat at the Big Table. The payment must be received prior to ANY of the Program services being provided. This includes the first in-person meeting or first coaching session.
- b. If the Client chooses a payment option, each payment will be made as set forth with our accounting department. Payments will be due on the 1st of the month or a penalty of \$25 will be assessed. In addition, a penalty of \$25 will be assessed for each additional 5 day period that the payment is late. All tuition is due in-full 10 days prior the first in-person session.
- c. Program privileges will be suspended for accounts that exceed 15 days past due. Admittance to in-person events will not be allowed unless past due amounts are paid in full.

6. Indemnification, Defense and Hold Harmless

Client understands that CRI/CP is in the business of coaching in the areas of business development and finance. CRI/CP does not provide any financial advice or financial consulting. As such Client further understands that Client is solely responsible for its decisions and actions. Client agrees to indemnify, defend and hold harmless CRI/CP, CRI/CP directors, CRI/CP instructors and all officers, owners agents, information providers, affiliates, coaches, licensors and licensees from and against any and all liability and costs, including, without limitation, reasonable attorney fees incurred by CRI/CP in connection with any claim arising from the use of materials or coaching provided by CRI/CP or its coaches. This includes consequential damages and any damages resulting from alleged negligence by CRI/CP, and its coaches.

7. Relationship of the Parties

Notwithstanding any other provisions in this Agreement, each Party shall be deemed to be an independent contractor and not as partner, joint venture, or agent of the other and shall not bind nor attempt to bind the other to any contract or obligation.

8. Assignment

Client may not transfer any obligations under this Agreement without the written consent of CRI/CP.

9. Notice

All notices under this Agreement shall be in writing, and shall be deemed given when personally delivered, or three days after being sent by prepaid certified or registered U.S. mail to the address of the party to be noticed as set forth herein or such other address as such Party last provided to the other by written notice.

10. Miscellaneous

No changes or modifications or waivers to this Agreement will be effective unless in writing and signed by both Parties. In the event that any provision of this Agreement shall be determined to be illegal or unenforceable, that provision will be limited or eliminated to the minimum extent necessary so that this Agreement shall otherwise remain in full force and effect and enforceable. In any action or proceeding to enforce rights under this Agreement, the prevailing Party will be entitled to recover costs and attorneys fees. Headings herein are for convenience of reference only and shall in no way affect interpretation of the Agreement. The laws of the State of California shall govern this Agreement.

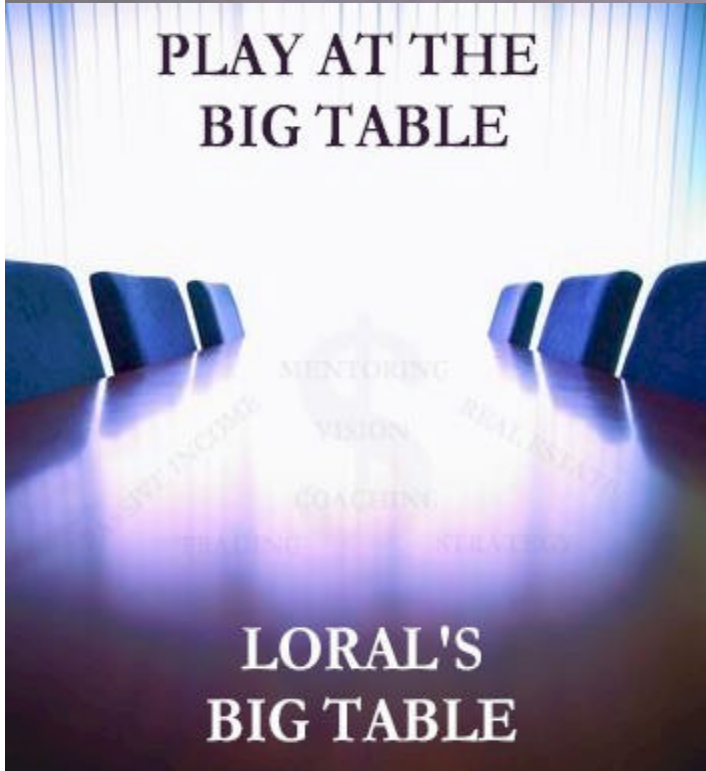
